

# Otago Water Polo – Player Code of Conduct

As a member of Otago Water Polo (OWP), I agree to uphold the following standards of conduct and behaviour:

#### **General Conduct**

- I will **play by the rules** and uphold the spirit of the game at all times.
- I will **follow all reasonable instructions** from coaches and team managers during practices, competitions, and other team activities.
- I will **wear the official club uniform** as directed, including arrival and departure at tournaments, practices, or events.

#### Attitude and Behaviour

- I will display a **positive attitude**, avoid disruptive behaviour, and give honest effort at training and competitions.
- I will show **respect and sportsmanship** to coaches, teammates, officials, volunteers, team managers, and the public.
- I will not use inappropriate language, gestures, or engage in verbal or physical harassment.
- I will refrain from any behaviour—physical or digital—that is intended to cause harm, injury, or embarrassment to another player.

### **Respect for Property and Others**

- I will respect **others' property**, the facilities we use, and any accommodation provided during tournaments or events.
- I understand that any deliberate damage to property may result in costs being passed on to me or my caregiver.

### **Substance Use**

• I will **not consume alcohol, tobacco, recreational drugs, or vape** while participating in any practice, event, or tournament held by or attended as a member of Otago Water Polo.

## **Health and Safety**

- I will comply with all pool and venue rules during practices and competitions.
- If I become **injured or unwell**, I (or my parent/guardian if under 18) am responsible for any **related costs**, including medical treatment and necessary travel or accommodation changes.

## **Conduct and Disciplinary Process**

- I understand that coaches and team managers are responsible for determining what is acceptable behaviour.
- Any complaints made by other players, coaches, managers, or members of the public will be reviewed by the
  Otago Water Polo Disciplinary Subcommittee.
- I may be asked to **meet with the Disciplinary Subcommittee** to discuss any complaint involving me.

### Possible outcomes include:

- Verbal or written warning
- Written apology and a probation period
- Suspension from games or competitions
- Early return from competitions at my (or my parent's) expense
- Suspension from the team or club
- Permanent suspension from Otago Water Polo
